You hereby warrant that you are fit and in good health and you accordingly waive any claim that you may have against the Mellon Housing Initiative arising from your participation in the Building Day(s) and you indemnify and hold Mellon Housing Initiative against any claim or action that may be instituted against Mellon Housing Initiative in respect of any injury you may sustain or loss or damage that you may suffer as a consequence of your participation as a Volunteer in the Building Day(s)
3. You must not use the Mellon Housing Initiative name, or your association with it, for any purpose other than to fundraise in respect of your involvement in the Volunteer Building Day(s).
4. The Mellon Housing Initiative reserves at its absolute discretion the right to refuse your application, in which case your registration fee of R500 will be returned to you.
